The following are dates that the ECC is **OPEN**, but the Mechanicsburg Area School District's kindergarten classes are not in session. **If your child attends** the ECC on these days, please be sure to include the required additional payment (\$19.00/day) with your weekly tuition, as stated in your parent agreement. Additional payment is also expected on days the public school is closed due to weather-related (or other) emergencies and your child is in our care during regular public kindergarten hours. The additional payment required for *early dismissal* days is \$12/day. The additional tuition expense is used to pay for the additional staff hours required to provide this care. *If your child does not attend the ECC on the days listed below, only the contracted weekly tuition amount is due.*

We ask that you notify the ECC office in advance of these days *in writing, at least two days in advance*, to let us know if your child will be here for those full days, so that the appropriate number of staff members is in place during those hours.
